The Global Symposium on Horse Racing took place at the Loew's Resort in Tucson, Arizona, from December 8 to 10.

Organized by the University of Arizona, this three-day conference is a key component of their Race Track Industry Program. The event featured a variety of topics, including:

- Equine Management and AI
- A national racing secretary summit
- Exploration of prediction markets
- ADW and CAW wagering issues
- Racetrack expansions

These are just a few highlights from the extensive learning sessions offered. The symposium also provided excellent opportunities for networking and collaborative brainstorming for the future of our industry.



## # Kansas Racing Commission Meeting Update 12/12/25

There was an engaging staff discussion regarding the flow of funds generated from HHR machines to the State, as well as the timelines for deposits into the Kansas Breeders Development Fund and the Race Benefit Funds. The conversation also touched on the accumulation of these funds and the potential for legislative actions to redirect them. It is important to note that these funds do not accrue interest. Next month, we anticipate the first report from Gilley to the KRGC on a monthly basis.
